## Dear Colleagues,

We have the great pleasure to invite you to the international conference *Towards a Good Society* – *European Perspectives*, which will be held between the 24th and the 26th of October in Bucharest at the Romanian Academy headquarters (Calea 13 Septembrie, nr 13).

The conference is organized by the Romanian Sociology Association, The Quality of Life Research Institute, and the Faculty of Social Sciences and Humanities of the University of Oradea, and will take place with the support of International Society for Quality-of-Life Studies (ISQOLS), International Sociological Association (ISA) and International Society for Child Indicators (ISCI).

**Topic.** After more than 20 years since the fall of communism and 9 years since the biggest enlargement in its history, the European Union is facing an economic crisis, which proves that the economic process in itself does not bring social welfare. The fact that we must extend the concept of social welfare becomes more and more clear, and the problems and uncertainties that our society is facing need new solutions. The international conference "Towards a Good Society – European Perspectives" will bring together theoretical and empirical contributions on this topic, from sociology as well as related fields, such as social work, political sciences, dempography and antropology. Scholars and professionals from the above-mentioned fields are expected to present their own work and to take part in the discussions.

The registration of the participants. Participants must register until the 18th of October 2013, confirming the payment of the conference registration fee (the bank account details will be displayed on the web page of the event). The 150 RON/35 EUR (100 RON/25 EUR for Masters Degree and PhD students) covers the presentation folder of the conference, as well as the meals and coffee breaks during the event. Organizers can offer lodging for free or at special prices for participants, in the order of requests and according to available places. People who have paid their Romanian Association of Sociology membership fee to date will be absolved from paying the participation fee.

**Publishing**. A selection of the presented papers will be published in a volume edited by Springer publishers and in special issues of the journals <u>Sociologie românească</u>, <u>Calitatea vieții</u> and <u>Inovația socială</u>. The papers will be selected through a process of double blind peer-review.
